BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to do by City forces the necessary work to relocate series lighting services to underground system and to relocate traffic signal services from overhead to underground systems on Harbor Drive between Broadway and Laurel Street and on Pacific Highway between Broadway and Palm Street pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$7,300 is hereby authorized from Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the work described above and related costs.
