

RESOLUTION NO. 205780

JUN 8 1972

WHEREAS, by Resolution No. 202547 dated April 27, 1971, this Council declared the following City streets to be one-way streets:

1. Franklin Avenue, one-way westbound, between San Miguel Avenue and 40th Street;
2. San Miguel Avenue, one-way westbound, between Los Pinos Avenue and Franklin Avenue; and
3. Jamul Avenue, one-way southbound, between Franklin Avenue and Cuyamaca Avenue;

and

WHEREAS, The City of San Diego has now received a request from the San Diego Urban League, Inc. and property-owner petition to remove the one-way street pattern; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the portions designated of the following City streets are hereby declared to be two-way streets:

- a. Franklin Avenue, between San Miguel Avenue and 40th Street;
- b. San Miguel Avenue, between Los Pinos Avenue and Franklin Avenue; and
- c. Jamul Avenue, between Franklin Avenue and Cuyamaca Avenue.

2. That the installation of the necessary signs and markings is hereby authorized to be made on said streets.

3. That the regulations hereinabove imposed shall become effective upon the installation of such signs and the removal of the one-way street signs.

4. That Resolution No. 202547, dated April 27, 1971, which established the above referenced one-way streets, be and the same is hereby rescinded.
