1. That the bid of \$274,913.10 by R. E. Hazard Contracting Co., A Corporation, for the IMPROVEMENT OF SANTO ROAD BETWEEN TIERRASANTA BOULEVARD TO 4,847 FEET SOUTHERLY OF TIERRASANTA BOULEVARD (Base Bid including Alternate 'A') in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 739710.
2. That the expenditure of \$305,000.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SANTO ROAD BETWEEN TIERRASANTA BOULEVARD TO 4,847 FEET SOUTHERLY OF TIERRASANTA BOULEVARD (Base Bid including Alternate 'A') in the City of San Diego, and related costs.
