Lassabe, Inc., A Corporation, for the LANDSCAPE DEVELOPMENT OF NORTH TORREY PINES ROAD BETWEEN GENESEE AVENUE AND LA JOLLA VILLAGE DRIVE (Base Bid including Additive Alternate 'A') in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 739445.
