1. That the bid of \$32,565.00 by V. R. Dennis Construction Co., A Corporation, for CHIRP PROJECT - PHASE IX (HUD CALIF. E-10) CONSTRUCTION OF ASPHALT CONCRETE SURFACE COURSE PAVEMENT IN LINDA VISTA ROAD BETWEEN TAIT STREET AND GENESEE AVENUE; AND IN ULRIC STREET BETWEEN TAIT STREET AND LINDA VISTA ROAD in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 739837.
2. That the expenditure of \$13,400.00 is hereby authorized out of the Gas Tax Fund (220) of the City of San Diego solely and exclusively for the purpose of providing funds for CHIRP PROJECT - PHASE IX (HUD CALIF.
