

RESOLUTION NO. 205806 JUN 13 1972

APPROVING MAP OF CANYON WOODS SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by SAMUEL F. SAFINO, Registered Civil Engineer, and entitled "CANYON WOODS Being a subdivision of Lot.1. of Swiss Village, according to Map thereof No. 6548, filed in the Office of the County Recorder of San Diego County, November 29, 1968, together with Lots 3 to 18 Inclusive; Lots 35 to 50 Inclusive, the unnumbered Lot lying North of Lot 3 and the unnumbered Lot lying North of Lot 50, in Block 1, Lots 37 to 46 Inclusive in Block 6, all in Fifth Street Addition, according to Map thereof No. 577, filed in the Office of the Recorder of said San Diego County on January 10, 1889, together with portions of Fifth Avenue and portions of Sixth Avenue all as vacated and closed to public use, all in The City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public

street and portion of street, to wit: Fifth Avenue and a portion of Sixth Avenue for public purposes and said street and portion of street are hereby declared to be a public street and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to  
the Clerk of the Board of Supervisors of the County of San Diego,  
California.
