APPROVING MAP OF TORREY PINES CONDOMINIUM SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by EMORY P. GIBLIN, Registered Civil Engineer, and entitled "TORREY PINES CONDOMINIUM Being a subdivision of a portion of Lot 1289 of The Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the Office of the Recorder of San Diego County, November 14, 1924, and is known as Miscellaneous Map No. 36, and a portion of Lot 1, of Azure Coast Unit No. 1 according to Map thereof No. 4995 filed in the Office of said County Recorder June 20, 1962.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1 and 2 of the certificate signed by the Owners for: general utility and access purposes, and open space; as granted and shown on said map and subject to the conditions expressed therein.
