WHEREAS, the Division of Highways, Department of Public Works, State of California, is in the process of acquiring rights of way for the purpose of the construction of State Highways 5, 15 and 252, in the City of San Diego; and

WHEREAS, portions of said freeways cross portions of Lots 1 through 8, inclusive, in Block "G" of Turnbull's Subdivision, according to Map thereof No. 1471 filed in the office of the County Recorder of San Diego County August 27, 1912, owned by The City of San Diego, and said Division of Highways, Department of Public Works, State of California, desires to purchase said City-owned property for said proposed freeways; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, said Division of Highways, Department of Public Works, State of California, has appraised said property and has offered to pay to the City the sum of Five Thousand Six Hundred Dollars (\$5,600.00) for a grant deed conveying said City-owned property, as more particularly described in said grant deed; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said property be sold to the State of California for the amount hereinabove recited; NOW, THEREFORE,

- 2. That the Mayor and the City Clerk of The City of San Diego, be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No.
