That Change Order No. 1, dated April 21, 1972, heretofore filed with the City Clerk of said City as Document No. 740242, issued in connection with the contract between The City of San Diego and Merle Tryon Concrete, Inc. for the pavement reconstruction at various intersections and in alley, Block 19, Fortuna Park Addition, said contract having been filed as Document No. 735989 in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$603.35, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$1,600 is hereby authorized from Capital Outlay Fund 245 solely and exclusively for the purpose of providing funds for the pavement reconstruction described above and supplementing Resolution No. 202632 by this amount and for this purpose.
