

RESOLUTION NO. 205831 JUN 15 1972

APPROVING MAP OF DESTY HEIGHTS SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by ALLEN D. RING, Registered Civil Engineer, and entitled "DESTY HEIGHTS Being a subdivision of a portion of the Southeast Quarter of the Northeast Quarter of the Northwest Quarter of Section 27, Township 18 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved February 25, 1870.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portions of streets, to wit: Desty Street, Desty Court, a portion of Elm Avenue and a portion of 27th Street for public purposes, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street those portions of Lots 8 and 9

marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and said Council has rejected those portions of Lots 8 and 9 marked "Reserved for Future Street" shown on this map within this subdivision all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
