RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CHANGES IN THE ASSESSMENT.

(Calle Del Cielo Assessment District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council adopted resolution of intention, Resolution No. 205602, ordering the City Manager to prepare the Report required by said Act, and, pursuant thereto, the City Manager has prepared said Report, consisting of plans describing the proposed improvements, an estimate of the costs and expenses of said improvements, a diagram showing the assessment district, and a proposed assessment of the costs and expenses of the proposed improvements, said Report being on file with the City Clerk; and

WHEREAS, the Council adopted Resolution No. 205603 approving said Report, as filed, and appointing a time and place of hearing thereon; and

WHEREAS, the Council adopted Resolution No. 205604 inviting bids for the purchase of bonds to be issued to represent unpaid assessments, and, pursuant thereto, bids have been received and opened prior to the time of said hearing; and

WHEREAS, the Pacific Telephone and Telegraph Company and the San Diego Gas and Electric Company have submitted cost figures in accordance with Paragraph 5b of the respective proposed agreements between the City and said companies; and

WHEREAS, based on the best responsible bids received for the purchase of the bonds, and based on said cost figures submitted by said utility companies, the actual costs differ from the estimated costs, as set forth in said Report, and by reason thereof the Council deems it advisable to change the amounts of the total assessment and the individual assessments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Section 1. The Council hereby orders that the assessment that the assessment be modified and that the amounts of the individual assessments and the total amount of the assessment be changed in accordance with Exhibit A of the "SCHEDULE OF CHANGES" attached hereto and made a part hereof and the Superintendent of Streets is authorized and directed to change the assessment, as filed with the City Clerk, in conformance therewith.
