

RESOLUTION No. 205847

Adopted on JUN 20 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Daniels Tire Service, 2. Dorman's, Inc., 3. George F. Kennedy, Inc., 4. The Armstrong Rubber Company, c/o Douglas Tire Company, 5. Wholesale Tire Company, 6. Marshall Tire Co., 7. Goodyear Service Store, 8. General Tire, and 9. B. F. Goodrich Co. are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of TIRES AND TUBES FOR TRUCK AND PASSENGER CARS as may be required for a period of one year beginning August 1, 1972 through July 31, 1973, as follows:

1. Daniels Tire Service for Groups I, V and VII; terms 2% 10 days, plus sales tax; prices firm;

2. Dorman's, Inc. for Groups II and VII; terms net 30 days, plus sales tax; subject to price escalation not to exceed 5% of bid price; with option to renew contract for an additional year;

3. George F. Kennedy, Inc. for Groups III and VII; terms 2% 30 days, plus sales tax; prices firm;

4. The Armstrong Rubber Company, c/o Douglas Tire Company, for Groups IV and VI; terms 3% 15 days, plus sales tax; prices firm;

5. Wholesale Tire Company for Group VII; terms net 30 days, plus sales tax; prices subject to manufacturer's increase; with option to renew contract for an additional year;

6. Marshall Tire Co. for Group VII; terms net 30 days, plus sales tax; prices firm; with option to renew contract for an additional year;

7. Goodyear Service Store for Group VII; terms 2% 30 days, plus sales tax; prices firm;

8. General Tire for Group VII; terms 2% 30 days, plus sales tax; prices firm;

9. B. F. Goodrich Co. for Group VII; terms 2% 30 days, plus sales tax; prices firm; with option to renew contract for an additional year.
