APPROVING MAP OF HOLLISTER HEIGHTS SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, Registered Civil Engineer, and entitled "HOLLISTER HEIGHTS Being a subdivision of a portion of the South Half of the North Half of the Northeast Quarter of the Northeast Quarter of Section 33 and also of the North Half of the South Half of said Northeast Quarter of the Northeast Quarter of Section 33, all in Township 18 South, Range 2 West, San Bernardino Meridian in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved February 25, 1870.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the portion of public street, to wit: portion of Leon Avenue for public purposes, and said portion of street is hereby declared to be a portion of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision and that said portion

of public street is accepted on behalf of The City of San Diego,
a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to
the Clerk of the Board of Supervisors of the County of San Diego,
California.
