WHEREAS, MILDRED PERRY WAITE is a graduate attorney from the University of Cincinnati, having practiced law in the State of Indiana; and

WHEREAS, she was appointed by the Mayor and Council to three City Charter Review Committees, in 1941, 1951 and 1961; and

WHEREAS, MILDRED PERRY WAITE has made numerous other contributions to public affairs and community betterment, including membership on the California State Board of the League of Women Voters; President of the American Association of University Women in San Diego; President of the Women's Cabinet of the United Fund; and organizing the San Diego Interracial Committee; and

WHEREAS, MILDRED PERRY WAITE received a Public Personnel Association Distinguished Public Service Award on October 23, 1969; and


WHEREAS, she received the Mayor's Distinguished Citizens Award on November 23, 1971; and
