That the Mayor and the City Clerk of said City be and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No. 740322, granting to San Diego Gas & Electric Company, a corporation, portions of Lots 29, 30, 31 and 32, Block 19, City Heights, according to Amended Map thereof No. 1007, filed October 3, 1906, in the Office of the San Diego County Recorder, as more particularly described in said form of grant deed.
- 3. That no broker's commission shall be paid by City on the herein described sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
