
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of Nine Hundred Fifty-five Dollars from the University City Woman's Club and directs that said contribution be deposited in Capital Outlay Fund 245 and thereafter be matched by an additional Nine Hundred Fifty-five Dollars from The City of San Diego to be used exclusively for the purpose of purchasing picnic tables, park stoves and benches for Marcy Park.

2. That the expenditure of Nineteen Hundred Ten Dollars from Capital Outlay Fund 245 is hereby authorized for the purpose of providing funds for the purchase of picnic tables, park stoves and benches for Marcy Park.

3. That this Council does hereby commend the University City Woman's Club for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the University City Woman's Club.
