APPROVING MAP OF CLIMAX UNIT NO. 22 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "CLIMAX UNIT NO. 22 Being a subdivision of a portion of Lot J of Lot 70 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Referee's Partition Map of a portion of said Lot 70 made in the action entitled 'San Diego Realty Co., a corporation, vs. Maria Y. Olvera De Toro, et al', filed in the Office of the County Clerk of said County in Civil Case No. 15191, together with a portion of Navajo Road as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Tommy Street for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is hereby accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of vehicular access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
