That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 15020, with the STATE DIVISION OF HIGHWAYS covering the RELOCATION OF SEWER LINES on Route 805 between the San Diego City limits and Imperial Avenue, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 740369.

BE IT FURTHER RESOLVED, that the expenditure of \$51,450, is hereby authorized out of Sewer Revenue Fund 506, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above project.
