WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Hobart W. Cross	PURCHASING DEPARTMENT	\$1,000	At the time of his suggestion Mr. Cross was in Utilities Customer Services. He noted that the system in effect for handling accounts in which meter readings were estimated resulted in a substantial loss in billing. This system, however, did save considerable cost of field trips. Mr. Cross proposed a computer program change for handling these accounts so that a net increase in revenue of nearly \$14,000 was made last year.
Raymond T. Savage	PUBLIC WORKS-CITY ENGINEER	\$970	Mr. Savage noted that City barricades and flashing lights were being provided to contractors for their work being done in City streets. He felt that contractors should pay for the use of this equipment, and actively worked for the development of a procedure for billing them. This has resulted in a net income of nearly \$10,000 last year from contractors.
