BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$51,143.00 by Wilcox Electric, Inc. dba Arrow Electric, A Corporation, for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF GOLFCREST DRIVE AND MISSION GORGE ROAD, AND AT GOLFCREST DRIVE AND NAVAJO ROAD in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 739971.
2. That the expenditure of \$60,000.00 is hereby authorized out of the Gas Tax Fund (220) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF GOLFCREST DRIVE AND MISSION GORGE ROAD, AND AT GOLFCREST DRIVE AND NAVAJO ROAD in the City of San Diego, and related costs.
