WHEREAS, pursuant to the San Diego Maintenance District Procedural Ordinance of 1969 (commencing with Section 65.0201, San Diego Municipal Code), this Council heretofore established the Emerald Hills Street Lighting Maintenance District by Resolution No. 203505; and

WHEREAS, pursuant to the aforesaid maintenance district proceedings the delinquency date of October 15, 1971, was established by the City Treasurer for payment of assessments; and

WHEREAS, on the aforesaid delinquency date the proposed maintenance had not commenced as a result of circumstances beyond the control of the City; and

WHEREAS, Section 65.0232 of the San Diego Municipal Code sets forth a procedure whereby the delinquency date previously established may be amended and authorizes the refunding or cancellation of all penalty payments collected or due; NOW, THEREFORE,

1. That the date of July 21, 1972, be and the same is hereby established and designated as the new delinquency date for the payment of assessments in connection with the Emerald Hills Street Lighting Maintenance District.
