

RESOLUTION No. 205926


Adopted on JUN 27 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the \$20,502.59 remaining in the San Diego Park District No. 2, Fund 369 (Lindbergh Park), used in connection with the San Diego Park District Procedural Ordinance of 1969 and the 1913 Improvement Act, be and the same is hereby declared surplus.

BE IT FURTHER RESOLVED, that the City Treasurer is hereby authorized and directed to credit said surplus in the manner provided in Sections 10427.1 and 10427.2, California Streets and Highways Code, pursuant to Resolution of Intention No. 197773, adopted August 19, 1969.
