Adopted on JUN 27 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$8,534 is hereby authorized from Grant Fund 2707, and the expenditure of \$9,378 is hereby authorized from Capital Outlay Fund 245, solely and exclusively for the purpose of providing funds for upgrading the law enforcement communications system of The City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for upgrading the law enforcement communications system pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
