RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO, CALIFORNIA, ORDERING CERTAIN  
CHANGES AND MODIFICATIONS IN THE WORK FOR  
THE IMPROVEMENT OF THE CENTRE CITY WAY  
PROJECT.

(CENTRE CITY WAY ASSESSMENT DISTRICT)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) this Council heretofore adopted Resolutions Nos. 201560 and 203504 ordering certain improvements in connection with the Centre City Way Assessment Project; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the work ordered; and

WHEREAS, Section 10352 of the Streets and Highways Code permits certain changes and modifications to be made without the necessity of a hearing; and

WHEREAS, neither the total amount of the assessment nor any individual assessment will be increased by reason of the aforesaid changes and modifications; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Change Order No. 2, dated April 4, 1972, heretofore filed with the City Clerk as Document No. 740485 in connection with the contract between The City of San Diego and

Mallcraft, Inc., for the construction of certain improvements in the Centre City Way Project under 1913 Act proceedings, said contract having been filed as Document No. 734608 in the office of the City Clerk, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$32,246.75 and an extension of time of 144 days extending the completion date to March 24, 1972, be and the same are hereby approved.
