BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$38,860 is hereby authorized out of Capital Outlay Fund 245, Programmed Reserves, solely and exclusively for the purpose of purchasing and installing certain materials and items of equipment at the Border Juvenile Check Station; and

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces all the work for the installation of such equipment and materials necessary for the operation of the Border Juvenile Check Station, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
