That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Amendment to the Joint Powers Agreement creating an agency to be known as the Southern California Coastal Water Research Project Authority, extending the period of the agreement to October 19, 1975, under the terms and conditions set forth in the form of Amendment to the Joint Powers Agreement on file in the office of the City Clerk as Document No. 740493.

BE IT FURTHER RESOLVED that the City Auditor and Comptroller is hereby authorized to expend a sum not to exceed \$50,000, from the Water Operating Fund 500 solely and exclusively for the above purposes.
