WHEREAS, by resolution of this City Council on March 2, 1971, two Certificates of Public Convenience and Necessity were authorized for Goodall's Charter Bus Service dba Airport Commuter Service, 5173 Baltimore Drive, La Mesa; and

WHEREAS, no Certificates of Public Convenience and Necessity were issued to said Goodall's Charter Bus Service dba Airport Commuter Service; and

WHEREAS, current fiscal year business license fees have not been paid by Goodall's Charter Bus Service dba Airport Commuter Service; and

WHEREAS, said Goodall's Charter Bus Service dba Airport Commuter Service has been inoperative for over thirty (30) consecutive days prior to this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council expressly finds that said Goodall's Charter Bus Service dba Airport Commuter Service has discontinued the service for which its Certificates of Public Convenience and Necessity were authorized; and, therefore, under the authority of San Diego Municipal Code, Section 72.15, the Certificates of Public Convenience and Necessity authorized to Goodall's Charter Bus Service dba Airport Commuter Service are cancelled.
