WHEREAS, by resolution of this City Council on July 7, 1970, six Certificates of Public Convenience and Necessity were authorized for San Diego International Tour Guide Services, 3943 Miramar Street, La Jolla; and

WHEREAS, one Certificate of Public Convenience and Necessity was issued to said San Diego International Tour Guide Services; and

WHEREAS, current fiscal year business license fees have not been paid by San Diego International Tour Guide Services; and

WHEREAS, said San Diego International Tour Guide Services has been inoperative for over thirty (30) consecutive days prior to this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council expressly finds that said San Diego International Tour Guide Services has discontinued the service for which its Certificates of Public Convenience and Necessity were authorized; and, therefore, under the authority of San Diego Municipal Code, Section 72.15, the Certificates of Public Convenience and Necessity authorized to San Diego International Tour Guide Services are cancelled.
