

RESOLUTION NO. 205988 JUN 29 1972

WHEREAS, by resolution of this City Council on May 19, 1970, three Certificates of Public Convenience and Necessity were authorized for Physician's Transport Service Company, 6066 University Avenue, San Diego; and

WHEREAS, two Certificates of Public Convenience and Necessity were issued to said Physician's Transport Service Company; and

WHEREAS, current fiscal year business license fees have not been paid by Physician's Transport Service Company; and

WHEREAS, said Physician's Transport Service Company has been inoperative for over thirty (30) consecutive days prior to this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council expressly finds that said Physician's Transport Service Company has discontinued the service for which its Certificates of Public Convenience and Necessity were authorized; and, therefore, under the authority of San Diego Municipal Code, Section 72.15, the Certificates of Public Convenience and Necessity authorized to Physician's Transport Service Company are cancelled.
