WHEREAS, Original Pied Piper Tours has indicated that it is discontinuing its business; and

WHEREAS, said Original Pied Piper Tours has been inoperative for over thirty (30) consecutive days prior to this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council expressly finds that said Original Pied Piper Tours has discontinued the service for which its Certificates of Public Convenience and Necessity were authorized; and, therefore, under the authority of San Diego Municipal Code, Section 72.15, the Certificates of Public Convenience and Necessity authorized to Original Pied Piper Tours are cancelled.
