BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$ 80,890.33 by L. R. Hubbard, Jr., An Individual dba Hubbard Construction Co. for the MODEL CITIES - AREA 11-1 PAVING AND OTHERWISE IMPROVING THE ALLEYS IN BLOCKS 189, 226, 227, 238, 239, 240, 241, 242 AND 243, SAN DIEGO LAND AND TOWN COMPANY'S ADDITION; THE CONSTRUCTION OF SIDEWALK IN SAMPSON STREET AND EVANS STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 739840.
2. That the expenditure of \$ 92,700.00 is hereby authorized out of HUD's Federal Grant for Model Cities Streets and Alleys Fund (2542) of the City of San Diego solely and exclusively for the purpose of providing funds for MODEL CITIES-AREA 11-1 PAVING AND OTHERWISE IMPROVING THE ALLEYS IN BLOCKS 189, 226, 227, 238, 239, 240, 241, 242 AND 243, SAN DIEGO LAND AND TOWN COMPANY'S ADDITION; THE CONSTRUCTION OF SIDEWALK IN SAMPSON STREET AND EVANS STREET in the City of San Diego, and related costs.
