

RESOLUTION NO. 206022 JUL 6 1972

WHEREAS, Section 102.0809 of the San Diego Municipal Code requires that the MAP OF POPULATION-BASED PARK SERVICE DISTRICTS OF THE CITY OF SAN DIEGO be presented at least annually to the City Council for review and ratification; and

WHEREAS, the second such map was adopted by Resolution No. 202545 on April 27, 1971, and is now due for review and ratification; and

WHEREAS, the map submitted for adoption is a refinement of the 1971 map revised to make minor adjustments in boundaries between some previously established districts, one additional district created by incorporating portions of two larger districts, the extension of two district boundaries into adjacent areas not included previously in any district, and the establishment of two new districts to accommodate new subdivision activity in previously undeveloped areas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That this Council hereby adopts the 1972 MAP OF POPULATION-BASED PARK SERVICE DISTRICTS OF THE CITY OF SAN DIEGO, a copy of which is on file in the office of the City Clerk as Document No. 740526.
