That Change Order No. 4, dated May 4, 1972, heretofore filed with the City Clerk of said City as Document No. 740554, issued in connection with the contract between The City of San Diego and WEARDCO CONSTRUCTION CORPORATION for the construction of the Sorrento-Rose Canyon Interceptor, Schedule I (Pump Stations 1 and 2), said contract having been filed as Document No. 735155, in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$6,004.07, and an extension of time of 90 days extending the completion to May 17, 1972, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$6,004.07, from the Penasquitos Sewer District Bond Fund 730, be and it is hereby authorized solely and exclusively for the purpose of providing funds for the contract changes described above.
