

RESOLUTION No. 206060


Adopted on JUL 11 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MAX M. LICHTY and FRANCES S. LICHTY, as to an undivided 5/6 interest; and MAX M. LICHTY as to an undivided 1/6 interest, executed in favor of The City of San Diego, bearing date of June 5, 1972, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 13 of Del Norte Addition to Encanto Heights Map No. 1193, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SPRINGFIELD STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
