RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO  
APPROVING REPORT UNDER THE SPECIAL ASSESSMENT IN-  
VESTIGATION, LIMITATION AND MAJORITY PROTEST ACT  
OF 1931 AND FIXING A DATE OF HEARING THEREON

(Cottontail Lane Assessment District)

WHEREAS, the City Council of the City of San Diego,  
did on JUL 11, 1972, by Resolution No. 208063,  
order the preparation of a report under the provisions of  
Division 4 of the Streets and Highways Code of the State of  
California, in the matter of the construction of certain im-  
provements in Cottontail Lane Assessment District; and

WHEREAS, such report has been prepared and submitted  
to this City Council,

NOW, THEREFORE, BE IT RESOLVED by the City Council  
of the City of San Diego, as follows:

1. That the report so prepared and presented be  
and the same is hereby approved and the fact and date of this  
approval shall be endorsed thereon and the report shall be  
filed with the City Clerk of The City of San Diego.

2. That the City Council does hereby fix the date  
of AUG 22, 1972, at the hour of 9:30 o'clock  
A.M., in the chambers of the City Council of The City of  
San Diego, located at the City administration Building, 202 "C"  
Street, San Diego, California, as the time, date and place  
when a hearing on said report will be held by the City Council.

The City Clerk shall give notice of such hearing by mailing a copy of the notice, postage prepaid, to all persons owning real property, which is proposed to be assessed to pay any part of the cost of the work, whose names and addresses appear on the last equalized assessment roll available on the date the report was commenced, at his address as shown on such roll, or as known to the City Clerk, all in the manner and form provided for in said Division 4 of the Streets and Highways Code.
