BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$49,800 from Park Bond Fund 725, Program Reserve to supplement Resolution No. 200388 in the amount of \$1,400, Resolution No. 203027 in the amount of \$14,000, Resolution No. 200103 in the amount of \$33,000, and Resolution No. 203183 in the amount of \$1,400.
