WHEREAS, The City of San Diego has made application to the Public Utilities Commission of the State of California for authorization to reconstruct the 47th Street Underpass in the City of San Diego; and

WHEREAS, it is anticipated that the Public Utilities Commission will approve the application; and

WHEREAS, upon receipt of approval from the Public Utilities Commission, the City will be making an application to the California Highway Commission for an allocation of State funds to reconstruct said 47th Street Underpass under the provisions of Section 190 of the California Streets and Highways Code; and

WHEREAS, the reconstruction of the 47th Street Underpass will be contingent on the allocation by the State of said funds and an agreement with the San Diego & Arizona Eastern Railway Company (S.D. & A.E. Ry. Co.) with respect to a contribution of ten percent of the total cost; and

WHEREAS, the terms of an agreement with S.D. & A.E. Ry. Co. have been established; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. The City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO & ARIZONA EASTERN RAILWAY COMPANY, a Nevada corporation, relating to the reconstruction of the 47th Street

Underpass, including financing, and the changes made in connection therewith, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 740600.

2. Funds for the cost of the reconstruction of said 47th Street Underpass will be allocated out of Gas Tax Funds, CIP 52-180.4(3), to defray the City's share of the cost of said reconstruction when the allocation of State funds is made and upon receipt of satisfactory bids for the reconstruction of said underpass.
