

RESOLUTION NO. 206088 JUL 18 1972

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where those portions to be vacated have been superseded by relocation; and

WHEREAS, those portions of Bedfont Avenue and Stanfield Avenue southerly of Hillery Drive; Woolwich Drive easterly of Greenford Drive; and Hillery Drive between the easterly line of Mesa Village Unit No. 1 and Greenford Drive have been relocated by the approval on this date of the dedication of Hillery Drive by the acceptance of the final map of the subdivisions to be known as Mesa Village Units Nos. 4 and 5; and

WHEREAS, those properties adjoining those above described portions of Bedfont Avenue, Stanfield Avenue, Woolwich Drive and Hillery Drive to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the subdivisions to be known as Mesa Village Units Nos. 4 and 5, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Bedfont Avenue and Stanfield Avenue southerly of Hillery Drive; Woolwich Drive easterly of Greenford Drive; and Hillery Drive between the easterly line of Mesa Village Unit No. 1 and Greenford Drive, as more particularly shown on Drawing No. 12799-B on file in the office of the City Clerk as Document
