BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a second amendment to agreement with FRANK L. HOPE & ASSOCIATES, ARCHITECTS AND ENGINEERS, a California corporation, amending an agreement dated May 6, 1969 and on file in the office of the City Clerk as Document No. 728056, and as amended by a first amendment to agreement on September 8, 1970, on file in the office of the City Clerk as Document No. 733486, for the design of administrative offices and repair shops in the San Diego Transit Corporation Central Operating Facility, under the terms and conditions set forth in the form of second amendment to agreement on file in the office of the City Clerk as Document No. 740679.

BE IT FURTHER RESOLVED, that the expenditure of \$17,200 out of Transit Central Operating Facility Fund 2572 is hereby authorized solely and exclusively for the purpose of providing funds for the architectural and engineering services described above.
