BE IT FURTHER RESOLVED, that the expenditure of \$12,500 is hereby authorized from Capital Outlay Fund 245 and \$1,500 is hereby authorized from Gas Tax Fund 219 solely and exclusively to provide funds for the professional services described above and related project expenses.
