WHEREAS, the Wells Fargo Bank, San Francisco, California, has by affidavit stated that on March 22, 1972, they mailed five coupons No. 7 from Bond Nos. 741/45, City of San Diego 1966 Municipal Improvement Series 2, 4.6% due April 1, 1990, to Wells Fargo Bank, Los Angeles, California; and

WHEREAS, the Wells Fargo Bank, Los Angeles, California, has by affidavit on May 10, 1972, stated that the coupons were not received; and

WHEREAS, Section 53460 et seq. of the California Government Code permits a city to issue new coupons to replace lost coupons; and

WHEREAS, the Wells Fargo Bank has provided an Open Penalty Indemnity Bond for securities lost or destroyed dated June 9, 1972, issued by Fireman's Fund Insurance Company holding City harmless against any and all costs; and


WHEREAS, the Council of The City of San Diego is satisfied that Coupon No. 7 from Bond Nos. 741/45, City of San Diego 1966 Municipal Improvement Series 2, 4.6% due April 1, 1990 (5 coupons at \$115 each) were lost or destroyed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer be and he is hereby authorized to issue five (5) new No. 7 coupons, dated April 1, 1972, at \$115 each to replace those lost or destroyed.

BE IT FURTHER RESOLVED, that the City Treasurer place in his files the affidavits of the Wells Fargo Bank and the bond written by Fireman's Fund Insurance Company.
