BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Bill Smith Sporting Goods, 2. Crosthwaite Athletic Supply, 3. Stanley Andrews Sporting Goods, and Folsom's Tennis Shop are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of 57 ITEMS OF MISCELLANEOUS ATHLETIC SUPPLIES for a period of one year beginning July 21, 1972 through July 20, 1973, per prices on file in the Purchasing Department as follows:

1. Bill Smith Sporting Goods for Items 1, 2, 4 thru 6, 9 thru 27, 32, 33, 35 thru 37, 39 thru 42, 44 thru 47, 52 and 57; terms 2% 30 days, plus sales tax; prices are firm;
2. Crosthwaite Athletic Supply for Items 3, 43, 51 and 59; terms 2% 21 days, plus sales tax; prices are firm;
3. Stanley Andrews Sporting Goods for Items 7, 8, 29 thru 31³⁴, 42, 48 thru 50, 55, 56 and 58; terms 2% 21 days, plus sales tax; subject to escalation not to exceed 5% of bid prices.
4. Folsom's Tennis Shop for Items 53 and 54; terms 1% 10 days, plus sales tax; subject to escalation not to exceed 5% of bid prices.
