BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$13,587.50 by WILCOX ELECTRIC INC., dba ARROW ELECTRIC, a corporation, for the TRAFFIC CHANNELIZATION AND MODIFICATION OF TRAFFIC SIGNAL SYSTEMS ON HARBOR DRIVE AT CROSBY STREET, AND METAL BEAM GUARD RAIL ON INGRAHAM STREET, PERSHING DRIVE AND 33RD AND "A" STREETS, INCLUDING ADDITIVE ALTERNATE "A" AND "B" in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 740065.
2. That the expenditure of \$16,000 is hereby authorized out of the Gas Tax Fund (Fund 220) of the City of San Diego solely and exclusively for the purpose of providing funds for the TRAFFIC CHANNELIZATION AND MODIFICATION OF TRAFFIC SIGNAL SYSTEMS ON HARBOR DRIVE AT CROSBY STREET, AND METAL BEAM GUARD RAIL ON INGRAHAM STREET, PERSHING DRIVE AND 33RD AND "A" STREETS, INCLUDING ADDITIVE ALTERNATE "A" AND "B" in the City of San Diego, California and related costs.
