That the law firm of Gray, Cary, Ames & Frye be employed and appointed as special bond counsel for giving an opinion on any bonds that may be issued in connection with the proposed proceedings under the Municipal Improvement Act of 1913 for the West Muirlands Drive Underground Utility District, pursuant to the terms and conditions set forth in the letter dated June 1, 1972, on file in the office of the City Clerk as Document No. 740754.

That in the event the proposed Improvement Act proceedings fail to materialize or are abandoned before an assessment has been levied and collected, the City shall not be liable for payment of any of the costs incurred in said employment.
