BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY, a Delaware corporation, for the engineering design and construction of automatic crossing gates at Cedar Street 231.3 (2-267.2) and 231.3 (2-267.25) Beech Street, respectively, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 740768.

2. That the expenditure of \$20,277 is hereby authorized from Gas Tax Fund 220, solely and exclusively to provide funds for the design, construction and related costs of the project described above.
