BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$6,400 is hereby authorized from Gas Tax Funds solely and exclusively for the purpose of providing funds for various minor modifications and improvements to nine existing traffic signals and two street lights at selected locations in the City.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work to make various minor modifications and improvements to nine existing traffic signals and two street lights described above pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
