APPROVING MAP OF VIA CATALINA II SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by SAMUEL F. SAFINO, Registered Civil Engineer, and entitled "VIA CATALINA II Being a subdivision of portions of Lots 22, 23, 24 and 25 of Catalina Villas, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1892, filed in the Office of the County Recorder of San Diego County March 11, 1926; together with a portion of the 15.00' wide alley between said Lots 22 and 23 as vacated and closed to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the street, to wit: Mendocino Boulevard, for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that the easement with the right of ingress and egress for the construction and maintenance of water facilities as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
