

**RESOLUTION No. 206165**


Adopted on AUG 1 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

The verbal appeal of Birdie L. Thompson and Rose D. Armstead, from the Street Superintendent's Assessment No. 3834, made to cover the costs and expenses of the work of paving and otherwise improving the ALLEYS, BLOCKS 99, 100, 130 and 131, REED AND SWAYNE'S CENTRAL PARK ADDITION, and the ALLEY, BLOCK 132, CENTRAL PARK; and ALLEY, BLOCK 101, FRINK AND WILDE'S SUBDIVISION, under Resolution of Intention No. 203272, adopted July 27, 1971, be, and they are hereby overruled and denied and all other appeals, written or verbal, are hereby overruled and denied.

BE IT FURTHER RESOLVED, that the Street Superintendent's Assessment No. 3834 is hereby confirmed and approved, and the Street Superintendent of said City is hereby authorized and directed to attach his warrant thereto and issue the same in the manner and form provided by law. Said warrant shall bear date of this order. The Street Superintendent of said City shall record in the office of said Street Superintendent said warrant, diagram and assessment. The City Clerk shall cause to be filed in the office of the County Recorder a copy of the assessment diagram and shall record a notice of assessment, as provided for in Section 3114 of the California Streets and Highways Code.
