for present or prospective public street purposes.

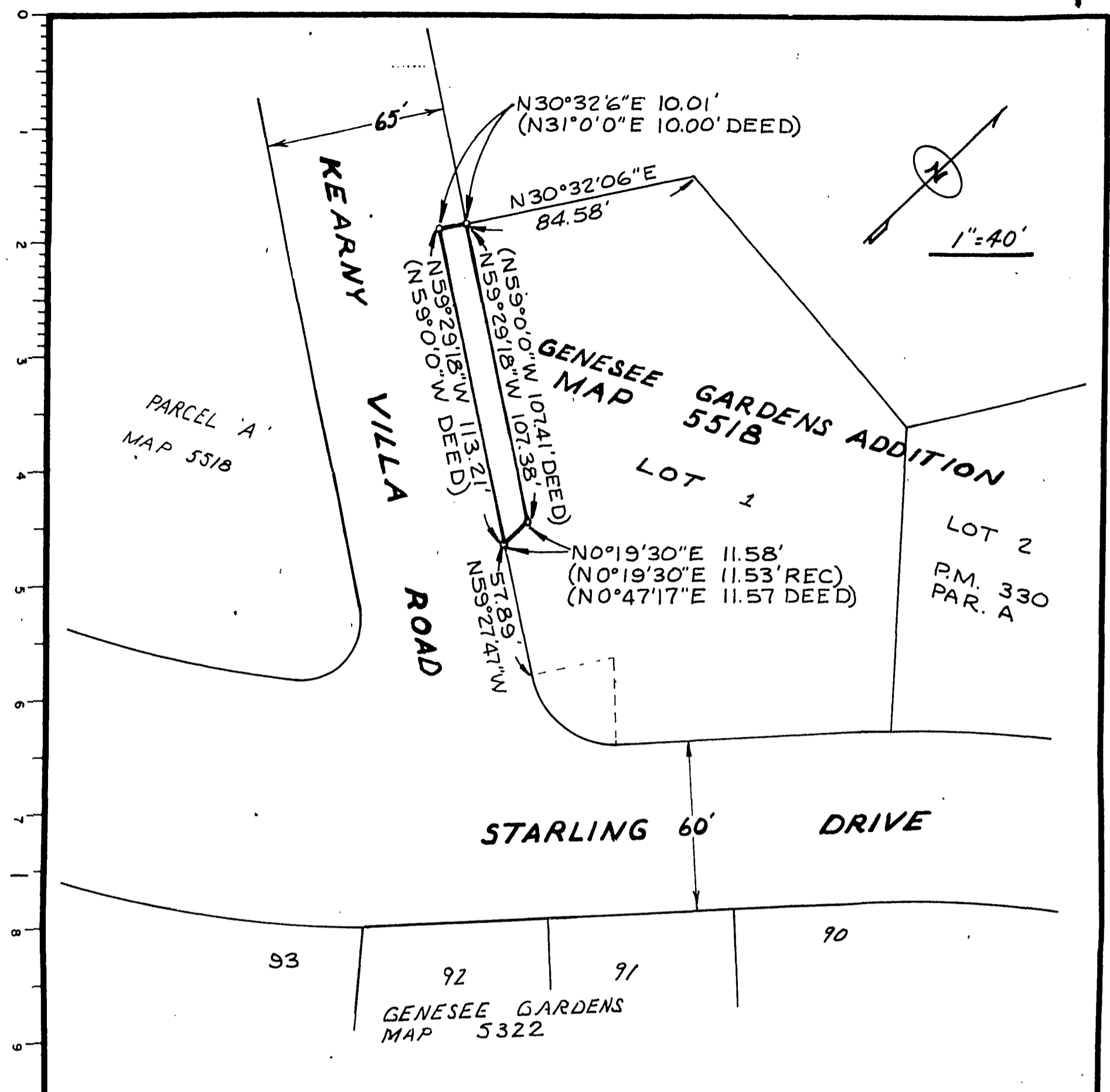
BE IT FURTHER RESOLVED, that a portion of Kearny Villa Road
