That Change Order No. 1, dated July 7, 1972, heretofore filed with the City Clerk of said City as Document No. 740843, issued in connection with the contract between The City of San Diego and C. E. Wylie Construction Co. for the construction of improvements in Plaza de Balboa, said contract having been filed as Document No. 739008 in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$7,539.00 and an extension of time of 30 days extending the completion to August 31, 1972, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$7,539.00 is hereby authorized out of Park and Recreation Bond Fund 725 solely and exclusively for the purpose of providing funds for the contract changes described above.
